

## **Junior/Senior Off-Campus Lunch Policies**

It is important that parents and students understand the expectations and rules governing off-campus lunch privileges. Your signature indicates that you have reviewed and discussed these regulations, are fully aware of the liability associated with this privilege, and acknowledge that this privilege may be revoked for violation of these rules and policies.

- 1. Parents/Guardian and students must sign the application in the presence of school personnel or have the application notarized by a certified notary.
- 2. Only students who have earned the required credits to be classifieds as juniors or seniors for the 2019-2020 school year may apply.
- 3. Students with off-campus lunch privileges must remain in good academic standing in order to maintain off-campus lunch. Privileges may be denied or revoked for the following reasons: **GRADES**, **ATTENDANCE**, **TARDINESS**, **or DISCIPLINE**.
- 4. All fines and fees must be cleared before applying for off-campus lunch privileges. Students with outstanding financial obligation will be denied.
- 5. Students with off-campus lunch privileges shall return to school for the remainder of the school day. Note: If student becomes ill while off campus, a parent/guardian must call the attendance office to properly check the student out. The student must present a parents note to the attendance office upon return to school. Failure to check out properly shall be treated as skipping.
- 6. Students with off-campus lunch privileges shall not take students off campus who are not authorized to leave. This includes other juniors and seniors who have not been granted permission. The student with the off-campus lunch privilege will have this privilege revoked for violation of this rule.
- 7. Students with off-campus lunch privileges shall maintain an acceptable record of conduct in accordance with the policies of HFA.
- 8. Students with off-campus lunch privileges shall return to class on time. If a student is late to his or her class from off-campus lunch, his or her privilege will be revoked.
- 9. Students with off-campus lunch privileges and their parents/guardians are responsible for where students go for lunch and for transportation. By signing this application, any student designated as a driver for off-campus lunch at any time during the use of his or her off-campus lunch privilege, and his or her parent/guardian, represent that the student carries a valid Texas driver's license and the minimum liability insurance required by state law.
- 10. Students with off-campus lunch privileges may not enter the cafeteria when they return to school, nor may they purchase food off campus to be brought to students.
- 11. No food, drink, or litter is to be brought into the building from the student's off-campus lunch.
- 12. Students exercising off-campus lunch privileges are not allowed to visit other school campuses while off campus during lunch.
- 13. HFA, HFLI, their administration, officers or employees assume no liability for the conduct or safety of any student, including any crime, accident or injury, committed or incurred in the exercise of this permit or at any time the student has left school grounds in the exercise of this permit.
